Information on members of the Supervisory Board appointed by the ordinary General meeting of Stalexport Autostrady S.A. on 14 April 2016

To supplement report no. 6/2016, the Management Board of Stalexport Autostrady S.A. (hereinafter referred to as the Company) provides information on Members of the Supervisory Board appointed by the Ordinary General Meeting of the Company on 14 April 2016.

1. Nicoló Caffo - Member of the Supervisory Board

Mr. N. Caffo graduated from University in Bologna, Civil Engineering (2002) and in 2008 Master in Business Administration (MBA) from Massachusetts Institute of Technology (MIT), Sloan School of Business, where he graduated in 2008.

In 2002 –2011 he worked in McKinsey and Company, a major strategic consulting company in the Milan office. Main projects included: an eight months reorganization of a major Italian bank, a due diligence of a merger between two major Italian banks, developing the two organizational frameworks for a real estate company, studying a design cost reduction for the main Italian railway company, participating to the profitability turnaround in the main Italian airline, a six-month project to create the Corporate Banking Department and the regional organization for a major Libyan bank, a five-month capability building project for a major Italian bank, an operational turnaround on three refineries in northern Nigeria, internal project on business development of McKinsey, a pricing and revenue management project in a major Greek Airline.

In 2007 he worked as a temporary Summer Associate for New York's office of Bank of America Securities in the Investment Banking Division, mostly in Initial Public Offering in automotive and real estate. Since 2011 he was hired by Autostrade per l'Italia S.p.A., International Business Development, where he is currently the Area Manager in charge of Poland and United States.

He advised clients in matters of company law, public-private partnership, project finance as well as administrative and civil law, with a special focus on public finance, public procurement, offset mechanisms, fair competition and motorway construction. In 2008-2010, he was Vice-president of Eko-Park S.A., and today is the Director of the Legal and Regulatory Office of PGE EJ1 sp. z o. o., a company which works on the construction of the first Polish nuclear power plant.

Aleksander Galos is a member of the Supervisory Board at ING Bank Śląski S.A., and in the years 2002-2011 was a member of the Bank Council at Bank Zachodni WBK S.A. and previously at PKO BP S.A. In 2016, he was appointed judge at the Polish Power Exchange Court.

(Venezuelan mobile operator), in years 2003-2006 as Vice-President of International Legal Affairs of TIM S.P.A.. in years 2006-2010 Vice President of International Commercial Contracts and Legal Compliance of Telecom

Italia Group. Since 2010 Vice-President of Executive Vice President of Legal Regulatory Affairs of Telecom Italia Sparkle S.p.A.

The above responsibilities have allowed Mr. Rossi to participate and lead major cross-border and multinational transactions for Telecom Italia/TIM Group.

Employed in Autostrade per l'Italia S.p.A. in the period January 2011-March 2015 as Head of International Business Development Projects.

He has been a tutor responsible for methodology issues within the Tempus Programme in European Company Law at the Faculty of Management of the University of Science and Technology in Krakow, and an associate professor at this university since 1999.
